## FY18 **ADVOCACY**

**During the 2017-2018 legislative session, Kempe advocated for policies and funding that support children, families and professionals working in the field of child abuse and neglect.**

### **HB 1306: Improving Educational Stability For Foster Youth**

Almost \$3 million in funding was appropriated for this bill that allows foster youth to stay enrolled in their home school by requiring that the county departments of human services determine the best way to transport the foster youth to that home school when they move.

### **HB 1348: Child Welfare Information And Services**

This legislation allows foster parents to have access to judicial and educational information about foster children and prioritizes individuals in foster care for access to the Colorado Child Care Assistance Program (CCCAP).

### **HB 1319: Services Successful Adulthood Former Foster Youth**

Approved by the house and senate and signed by the governor, now county departments of human services are required to extend housing, employment, education, mental health care and substance abuse treatment services to former foster youth ages 18 to 21.

We will continue to examine substance abuse disorders and the opioid crisis in Colorado. With the passage of **HB 1003: Opioid Misuse Prevention**, the Opioid and Other Substance Use Disorders Interim Study Committee will continue until 2020. The bill also contains several provisions to create education programs to help prescribers safely prescribe opioids, along with funding for grants for screening, education, intervention and prevention.

Although we, along with our stakeholders, expressed concern with **HB 1258: Marijuana Accessory Consumption Establishments**, which allows retail marijuana establishments to sell marijuana concentrate and other products for onsite consumption, it passed the House and Senate, and received the Governor's signature. We continue to advocate for responsible regulation of marijuana, with a primary focus on the legislation that effectively and appropriately considers the safety, health and well-being of our children, youth and families.
