A Letter from Jon Kruljac

CEO, THE KEMPE FOUNDATION

This past year for Kempe was one accentuated with community events and celebrating meaningful milestones, including the 50th Anniversary of The Kempe Center. Fifty years after Dr. C. Henry Kempe launched the groundbreaking Center to transform our field, all of us must rise together to address the increasing challenges faced by vulnerable children and families.

Over 300 people took part in celebrating the 50th anniversary of the Kempe Center's founding. The celebration served as a reminder of the pioneering spirit of Dr. Kempe and his successors, who have worked tirelessly to improve the lives of children impacted by trauma, abuse, and neglect. We recommenced Kempe's Uniting Communities Breakfast series by assembling stakeholders from all over the state for a discussion centered on children's mental health and the prevention of youth suicide. The most poignant comments at the breakfast were from the high school students, who wish to be empowered to find remedies for their peers from

this devastating crisis. The Kempe Ambassadors hosted the inaugural Taproom Takeover for nearly 100 friends and supporters to learn about the Child Welfare Training System, a state funded program whereby Kempe professionals train every child welfare case worker and supervisor aimed at improving the care of the children. The community exhibited unprecedented support for our mission during Colorado Gives Day, joining with Kempe Foundation board leadership to raise a record amount of funding for Kempe programs and research. All these community activities are positive reactions in the aftermath of the pandemic, which caused great turmoil and increased stress, though especially amongst our most vulnerable populations.

We are encouraged by continued progress of Kempe programs, such as trainings conducted by the Child Abuse Response & Evaluation Network (CARE Network), proven to be a valuable resource to pediatricians, nurses, and other mental health workers, in identifying and treating children who may have been mistreated. Further research on Fostering Healthy Futures has demonstrated tangible benefits through its curriculum rooted in positive youth development. We are working with the CU Department of Psychiatry in the expansion of direct clinical services for children suffering from a mental and behavioral health issue. Lastly, with the support of corporate partners, we have begun to explore ways to proliferate our Trauma Responsive Implementation & Practice (TRIP) program in schools. TRIP in schools imparts skills to teachers, administrators, students, and parents on

a holistic basis on how to identify and react to stressors and trauma that find their way into the classroom.

We continued advocating for children and families in our state through public policy efforts. We are heartened by the focus on Colorado's youth through the formulation of the Department of Early Childhood and its inclusion of trauma-informed language. We were also ardent supporters of HB 21-1258 which established the I-Matter Program which provides free, on-line consultations for youth under the age of 18 who are experiencing mental health issues. We will continue to work with all stakeholders to secure sustainability of initiatives that improve the well-being of children and families.

We are grateful for our donors, partners, volunteers, board, and corporate sponsors for stepping up to meet the critical needs of today. We couldn't do this work without you, thank you. We look forward to a horizon full of hope, safety, and wellness for children everywhere.

50+ YEARS of *History*

The Kempe Center is a living legacy to a brilliant researcher, teacher and prominent pediatrician who became one of America's pioneers in the prevention and treatment of child abuse and neglect. During his professional career, Dr. C. Henry Kempe received two nominations for the Nobel Prize. The first nomination was for his work in developing a safer smallpox vaccine, which helped eradicate this childhood disease around the world. The second nomination was recognition for his contribution to the prevention and treatment of child abuse. Today, 50 years later, The Kempe Center is recognized as a world leader in innovative solutions to prevent and treat child abuse, neglect and trauma.

Key Historical Figures

During the past 50 years, these individuals dedicated their lives to the creation and growth of The Kempe Center in support of children and families all around the world.

Dr. C. Henry Kempe

In 1962, Dr. Kempe and his colleagues exposed the reality of child abuse for the first time in their defining paper, *The Battered Child Syndrome*. This paper is lauded as the most significant event to give doctors a way to identify and understand child abuse. Inspired by these findings, Dr. Kempe founded The Kempe Center for the Prevention and Treatment of Child Abuse and Neglect in 1972 to improve the care and well-being of children and families.



Dr. Donald Bross

Dr. Don Bross was an Associate Director for Pediatric Law, Policy and Ethics at The Kempe Center and Children's Hospital Colorado, using his expertise in law, medical sociology, and pediatrics to expand solutions for those impacted by child abuse and neglect. Don represented children in court for more than ten years and has published over has more than 100 publications over his career.



Walt and Georgia Imhoff

The Imhoffs left a legacy to The Kempe Foundation that will live on forever due to their extreme dedication to the growth of the Foundation to help as many children and families as possible. They became involved with the Foundation in 1984 and inspired thousands of individuals to give and volunteer towards Kempe's philanthropic efforts.



Dr. Ruth Kempe

Dr. Ruth Kempe was a pioneer in treating victims of child abuse and impacting families. She worked together with her husband, Dr. C. Henry Kempe, to launch the National Center for the Prevention and Treatment of Child Abuse and Neglect in 1962, which eventually would be called the Kempe Center. She worked locally and nationally on policy initiatives to impact change.



Dr. Richard Krugman

Dr. Krugman, former Vice Chancellor for Health Affairs and Dean at the CU School of Medicine for 25 years and former Executive Director of The Kempe Center, is a distinguished professor in pediatrics and child abuse and neglect at the Kempe Center. He is one of the preeminent experts and scholars in the field of child abuse and neglect in this country and a protégé of Dr. Kempe.



Dr. Gail Ryan

Gail began working with Kempe in 1976 in the first year that the Kempe Foundation was founded. She trained hundreds of trainers in more than 20 states to use the Kempe curriculum she developed called the Kempe Perpetration Prevention Program which uses a Public Health approach to primary, secondary, and tertiary prevention to reduce the risk of children becoming abusive to children: as children, as adolescents, and ultimately as adults.



Dr. Brandt F. Steele

In 1962, CU medical pioneers Dr. Steele, Dr. C. Henry Kempe and Henry Silver, MD, published the paper "The Battered-Child Syndrome," a groundbreaking study that shined light on a societal scourge that had long lurked in the shadows. The paper, which documented 300 cases of abuse, was pronounced one of the 20th century's 50 most important medical contributions by the *Journal of the American Medical Association*.

Accomplishments



1958

Kempe created one of the first Child Protection Teams to identify and treat child abuse. It is ongoing today.

1962

Doctors C. Henry Kempe and Brandt F. Steele published their landmark article "The Battered Child Syndrome" in the Journal of the American Medical Association.

1972

The Kempe Center opened with one vision: to recognize that children were being abused, the threat was real, and we must do something about it.

1973

First Crisis Nursery created, which provided care for abused and neglected children. Today, a crisis nursery is found in most communities throughout the United States of America.

1974

First Therapeutic Preschool opened, providing a day treatment facility for abused children.

1976

The Kempe Foundation, an independent 501(c) (3) nonprofit organization, was founded to raise the needed funds and awareness, and engage in advocacy to create sustainable support for the work of The Kempe Center.

1977

The International Society for the Prevention of Child Abuse and Neglect was organized with publication of the first issue of Child Abuse and Neglect: The International Journal.

1983

National Adolescent Network was created to provide information to professionals working with adolescent sex offenders.

1991

Research and support groups were established for survivors of childhood incest.

1993

Prevention Research Center was created to serve as the primary knowledge base for public policy relating to home visitation services to support young families.

1994

Kempe Foundation initiates a \$4.4 million capital campaign to construct a 35,000-square-foot facility for the Kempe Center. It's completed 2 years later.

- 1997** Groundbreaking and completion of the Georgia and Walt Imhoff Pavilion, new home of The Kempe Center and Foundation.
- 1999** Kempe Foundation secures 1st Endowed Chair – the Jack and Viki Thompson Chair in Child Maltreatment and Family Health.
- 2000** Kempe Foundation secures 1st Endowed Fellow – the Berger Fellow.
- 2002** Kempe Center hosts the 14th International Congress on Child Abuse and Neglect.
- 2002** Fostering Healthy Futures (FHF) is formed to implement an evidence-based mentoring and skills training program for youth with child welfare involvement or who are at risk for child welfare involvement.
- 2005** Kempe Foundation initiates a \$12.2 million Capital Campaign to move The Kempe Center and the Foundation's headquarters to the CU Anschutz Medical Campus, to be amongst a renowned medical center of excellence and enhance its collaboration with Children's Hospital Colorado, and work with colleagues at the University of Colorado.
- 2006** Kempe Foundation celebrates its 30th anniversary and launches the Get Your Blue On for Kempe Kids awareness campaign.
- 2008** Kempe Foundation awarded "Nonprofit of the Year" by the Denver Metro Chamber of Commerce.
- 2009** Kempe moves into the new Kempe Center at the Gary Pavilion on the Anschutz Medical Campus. This created a world-class comprehensive child abuse and neglect center integrating clinical treatment, research, policy analysis and advocacy all together in one location.
- 2012** The Kempe Center offers mental health services to children and families through the Improving Mental Health Of Families (IMHOFF) clinic
- 2013** Kempe begins to work alongside the Colorado Department of Human Services (CDHS) to revolutionize child welfare through the formation of the Child Welfare Training System (CWTS).
- 2019** During the Colorado legislative session, the Kempe Foundation and Kempe Center partnered with counties, state agencies and other stakeholders to pass House Bill 1133. The bill, now law, created the Child Abuse Response and Evaluation (CARE) Network.
- 2020** The Kempe Center hosted the hugely successful Inaugural Call to Action to Change Child Welfare attended by over 1400 participants from 20 different countries.
- 2021** The Interdisciplinary Trauma-Sensitive Assessment & Treatment Services for Kids (TASK) Clinic opens to provide comprehensive assessment and direct treatment services for children ages 3-12. TASK offers high quality, comprehensive assessment of physical, mental/behavioral health, socio/emotional well-being, cognitive, and developmental functioning.
- 2022** Kempe celebrates 50 years of progress.



Expanding Our Reach

The Kempe Foundation broke ground on the CU Anschutz Medical Campus to be a leader in collaboration and innovation for medical professionals focusing on the prevention and treatment child abuse, neglect and trauma. Kempe collaborates with agencies around the country and throughout the world to offer training, evaluations, technical assistance, research and clinical consultations to serve as a robust multidisciplinary medical program.

Kempe in Colorado

The Kempe Center serves as a section of the University of Colorado School of Medicine, Department of Pediatrics, which is affiliated with Children's Hospital Colorado. These are Kempe's most important partnerships, which provide clinical expertise, advocacy assistance, research opportunities and evaluation that result in increased capabilities and resources and heightened academic credentials and reputation. The Kempe Center is comprised of 75 professionals with many working out of the home offices in Colorado.



Kempe Around the Country

The Kempe Center provided services in 19 states this past fiscal year through clinical care, clinical consultation, research projects, journal articles/publications, professional trainings, and technical assistance. Kempe research, knowledge and trainings impact experts in the field, medical professionals, children, youth and families throughout our country.

Kempe Around the Globe

Dr. Kempe had a vision to end child abuse around the globe and the Kempe community continues to partner with advocates from all over the world to impact children and families.

Kempe hosted their second annual virtual conference, "A Call to Action to Change Child Welfare," welcoming 1,750 participants and 500 speakers from 20 countries, covering 225 different sessions for 16 hours daily for 4 consecutive days. Conference themes and topics included Children's Well-Being, Community Well-Being, Economic Well-Being, Family Well-Being, Healthy Systems, Promoting Health and Well-Being and Workforce Well-Being.

The conversations inspired ways to work with children, youth, families and communities that promote health, well-being, restoration and healing. The event creates an international community by launching an online space to re-envision and rethink child welfare through mobilizing child, family, and community partnerships and leadership.

International Journal on Child Maltreatment

Research, Policy and Practice

The International Journal on Child Maltreatment is a groundbreaking forum for presentation and analysis of innovative research, programs, and policies for and about prevention, control, and mitigation of child abuse and neglect. The journal is published in partnership with two leading organizations: The Kempe Center and The Haruv Institute out of Israel. The journal is a peer-reviewed, interdisciplinary journal that serves as a forum for innovative efforts to promote policies, interventions, and programs focused on the safety, protection and welfare of children. The journal publishes original scholarly works including empirical research, reviews, commentaries, brief reports, program evaluations and innovations, and book reviews. Several Kempe professionals sit on the editorial board of the publication.

Together

We're Making an Impact

Through Dr. C. Henry Kempe's efforts, child abuse reporting laws now exist in all 50 U.S. states. Kempe's work led to the passage of the 1972 Colorado law requiring legal counsel for the child in all cases of suspected abuse. In 1976, The Kempe Foundation was established to lead fundraising, awareness, and advocacy efforts for children. The Kempe vision remains aligned with Kempe's overarching passion: "Our children's future and the world's future are one." Donations to The Kempe Foundation in fiscal year 2022 supported our work in the following areas:



Fostering Healthy Futures

The Fostering Healthy Futures (FHF) program is an evidence-based, positive youth development program for preteens and teens who are in foster care or at risk of out-of-home care due to abuse and/or neglect. The program uses a combination of individual mentoring and skills training to promote healthy development, strong interpersonal connections, and multiple competencies in young people with exceptional promise, thereby reducing risk factors for adverse outcomes, including substance use, violence and delinquency.

In FY22, FHF continued to train, implement and disseminate the FHF program model to other youth-serving organizations across

Colorado. Preliminary results demonstrate 89% of enrolled children completed the 9-month program (during the pandemic) and over 90% of the ratings of each training aspect, on anonymous surveys completed by implementing staff, were positive or extremely positive. These results were in addition to the numerous positive outcomes, such as better mental health functioning and lower rates of delinquency and involvement in the juvenile justice system, demonstrated previously. After over twenty years of research, we are pleased to report that FY22 became the first year of implementation, dissemination and accreditation.

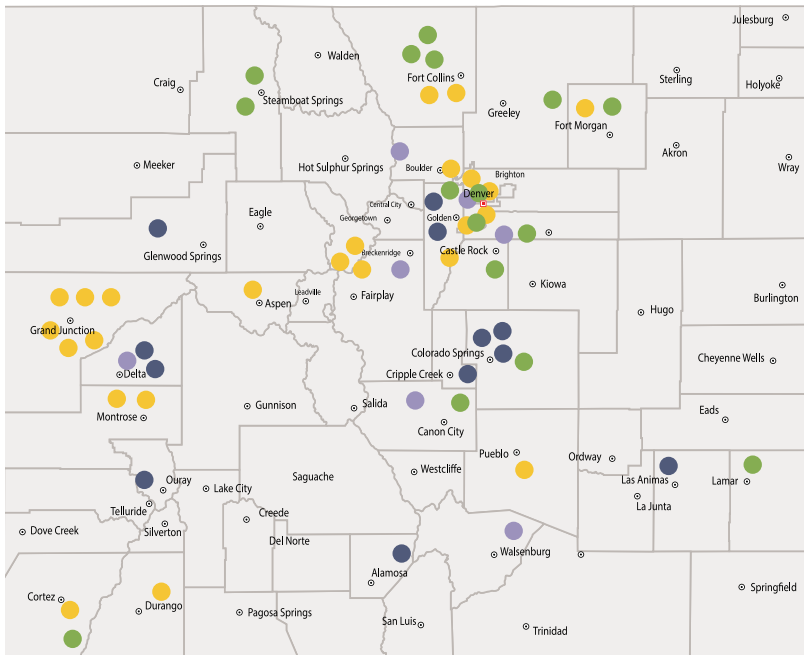
Expanding the CARE Network Across Colorado

Established through House Bill 19-1133 in 2019, the goal of the CARE Network is to create a state-funded healthcare network to provide a standardized response to suspected child maltreatment. This past year, CARE Network providers represented 28 counties throughout Colorado. Our network of medical providers (physicians, physician assistants, nurse practitioners, and forensic nurse examiners) include experts in the area of pediatrics and

emergency medicine. In addition, our behavioral health providers are trained in evidence-based trauma treatment modalities, child development, trauma, complex-trauma and family systems. Each evaluation conducted by CARE Network providers is reviewed by a board-certified Child Abuse Pediatrician (for medical exams) and a Licensed Psychologist (for behavioral health assessments) to rate provider adherence to best practice guidelines for discipline

specific assessments. The expansion and retention of providers so that quality care is not hindered by geography or distance remains a CARE Network priority. Research shows that children with high needs are more likely to be abused and neglected, thus identifying and getting children referred for treatment may help prevent future abuse and neglect.

SafeCare®

This evidence-based prevention program offers proactive, in-home, voluntary services that support at-risk families in gaining skills to provide a safe home, address child health needs, and engage in positive interactions with their children ages 0 to 5- years-old. The services are delivered in the family's home by trained professionals on a weekly basis. In FY22, 949 families participated, 10,556 visits were provided and 1,095 topics were completed.





Advancing Child-Focused Policies at the Capitol

Following the 2021 “State of Emergency” declaration by Children’s Hospital Colorado, the mental and behavioral health of Colorado’s children and youth remained a high priority for the Kempe Foundation during the 2022 legislative session. Dr. Sue Kerns, Kempe Center, was appointed to the advisory Task Force supporting the Behavioral Health Transformational Task Force, a legislative committee tasked with investing over \$450 million of federal American Rescue Plan Act funds towards transformational change in Colorado’s behavioral health infrastructure. Dr. Kerns elevated the voice of children, youth, and families throughout the process, ensuring that the implementation legislation included a focus on prevention and early intervention for Colorado’s youth.

The 2022 legislative session had an increased focus on supporting our youngest Coloradans through the newly created Colorado Department of Early Childhood. The Kempe Foundation was instrumental in ensuring that evidence-based family strengthening programs, alongside traditional universal preschool programs for a holistic approach to strengthening communities, was included in policy activity. In partnership with state lawmakers and child welfare agencies, we actively engaged in efforts to secure funding for critical Kempe Center programs and pass legislation focused on the protection of children and supports for families.

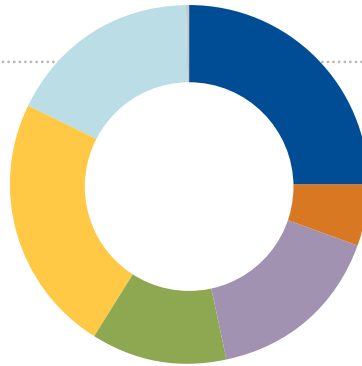

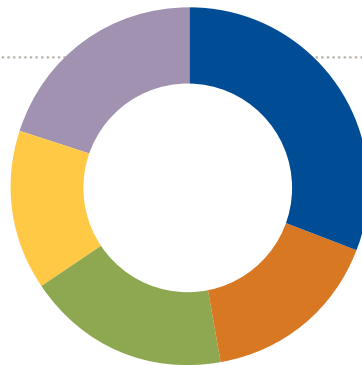
